1.0 Introduction and Policy Statement

- 1.1 Brenton USA, hereafter Brenton, recognizes that our success is linked to the success of our network of select authorized dealers. Brenton chooses to promote the quality of Brenton products in part by promoting agreeable relationships with our dealers, while at the same time protecting Brenton interests and public opinion(s) of Brenton products.
- 1.2 Brenton, at its sole discretion, reserves the right to impose sanctions upon a re-seller, up to and including termination of re-seller status and discontinuation of business.
- 1.3 Brenton reserves the right to not provide preceding notice before taking action under this agreement.

2.0 Confidential and Non-Compete

- 2.1 Information pertaining to pricing, intellectual property, contracts, and any other data that could be used by a competitor of Brenton will be considered confidential.
- 2.2 Re-seller will not copy, reverse engineer, or re-design any Brenton products with the intent to reproduce, manufacture, distribute, or sell during the duration of this agreement or for forty-eight (48) months after the termination of this agreement.

3.0 Re-seller pricing

- 3.1 Re-sale pricing shall be at the sole discretion of the Re-seller.
- 3.2 Re-seller may sell Brenton products using third party channels (ex. GunBroker or other alternate auction sites).

4.0 Orders

- 4.1 Brenton maintains a minimum \$1000 order policy.
- 4.2 Orders will be filled on a first-come first-served basis, and expected delivery can be provided to re-seller preferred contact at time of order.

5.0 ITAR Export Control Notice

- 5.1 Certain Brenton products may be subject to the Arms Export Control Act (AECA), and other applicable federal agencies and laws. Brenton is committed to compliance with all applicable federal regulations concerning the import and export of firearms and associated components and technology. By signing this agreement, you agree to not export or purchase with intent to resell for export any ITAR restricted products from Brenton without the required U.S. Department of State or Department of Commerce license or other authorization for the direct export of controlled commodities.

6.0 Excise Tax Notice

- 6.1 Certain Brenton products may be subject to the imposition of tax when combined with other certain products produced by Brenton and or other manufacturers. Brenton is committed to compliance with all applicable federal regulations concerning the manufacture, transfer and sale of firearms. By signing this agreement, you acknowledge that it is the responsibility of the re-seller (you) to know and observe all requirements associated with 27 CFR 53.
